The second partner meeting

On Tuesday, 5th of March 2013 there were presentations and discussions about:

- the Framework of Education belonging to the Internal Audit system of Education (self-evaluation for teachers and management involved in education; research documents; a complete education control system)
- the framework for “the trust of local industry” belonging to the education
- the communication in Fronter and the information on the website

On Wednesday, 6th of March 2013 there were presentations and discussions about:

- the organisation- and administration aspects of the project
- the presentation of all partner dissemination plans
- the schedule of the partner meeting in Finland

The Framework of Education belonging to the Internal Audit system of Education

Partners decided that the Internal Audit system including (self-evaluation for teachers and management involved in education, research documents a complete education control system) should be based on standards of education. Partners will make these standards in June 2013.

All partners have a system to look after the quality of education in school and in the work placement. It is important to get information and feedback from the students and local industry. There should be described on what level the knowledge, skills and attitude of beginning professional should be. We have to evaluate students before and after studies, we want to have feedback about the environment, study, the teaching and the organisation of the education.

Some partners have in their country a national evaluation system used by the government or the Ministry of Education.

In the project meeting in June 2013 the partners will decide how many evaluations we need, how much is reasonable and if you collect information you should use this, otherwise it is a waste of people's time.

The partners will bring in all their Internal Audit systems and they will make together one system and test this system in the end of this year.

The framework for “the trust of local industry” belonging to the education

The partners decided that it is important to develop the education together with the real workers of the local industry. All education units in schools should use the same framework for “ the trust of local industry”.

The framework should describe the cooperation on the level of strategy and also on the operational level in education.

Communication in Fronter and the information on the website

Partner AXXELL built a communication platform in Fronter where partners work together on their project activities.
